### **Scope**

- a) Bureau Veritas is the appointed verifier for organisational and activity based GHG. Verification of evidence will be performed in accordance with ISO 14064 on Evercomm's NXMap. After each verification, the platform digitally produced 'certificate' will have a reference number traceable to Bureau Veritas's issued External Statement of Assurance.
- b) Bureau Veritas is the appointed trainer for Sustainability and GHG Awareness course. This one-day course is to complement Evercomm's one-day NXMap on-boarding training for their new customers.
